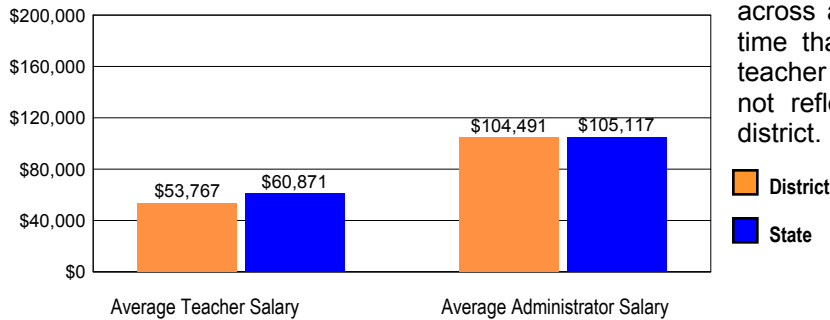

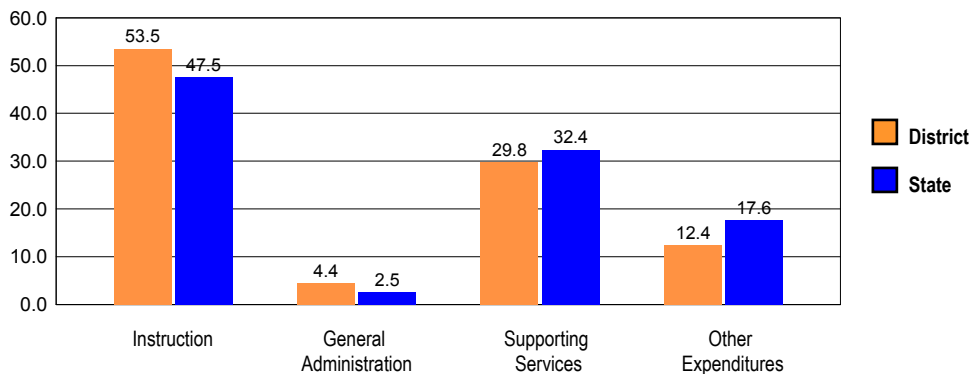
SCHOOL DISTRICT FINANCES

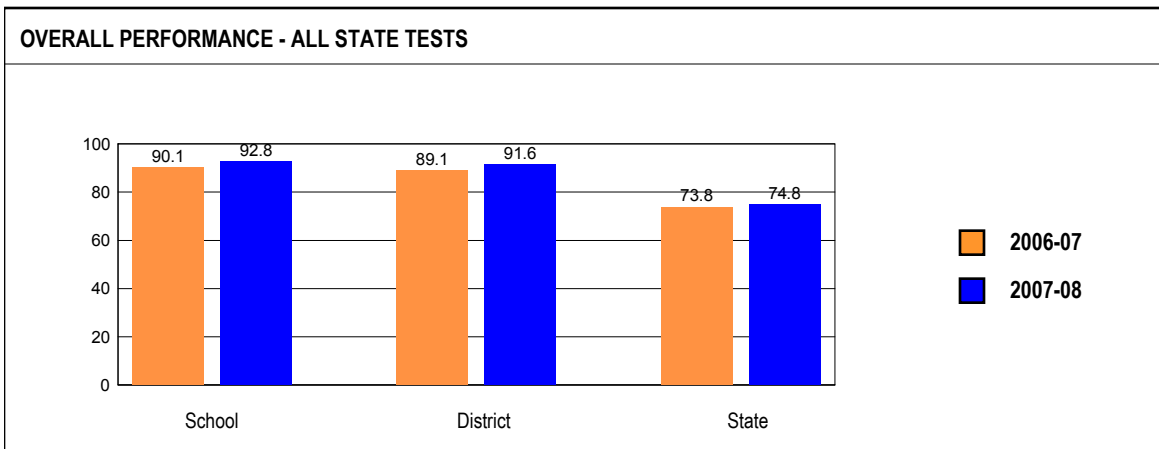

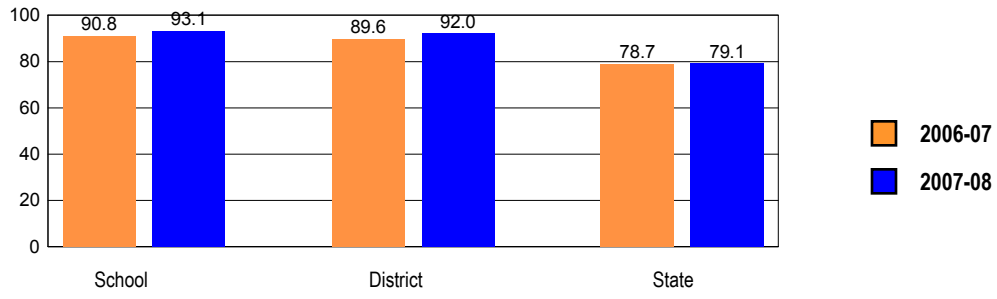

OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

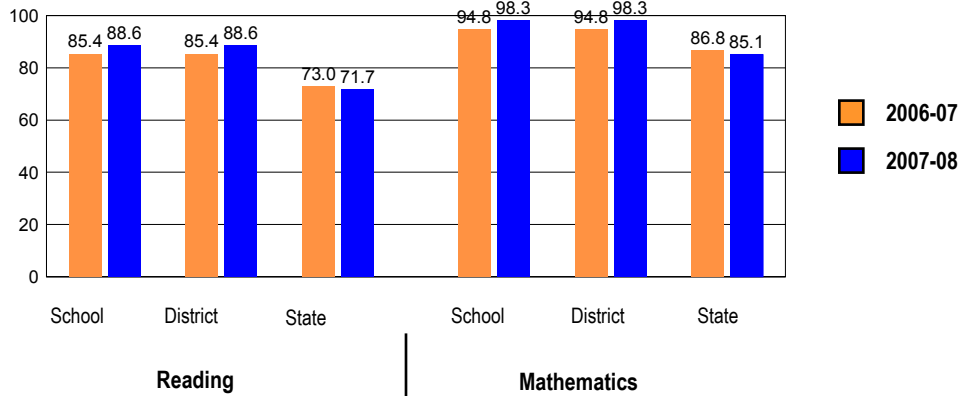

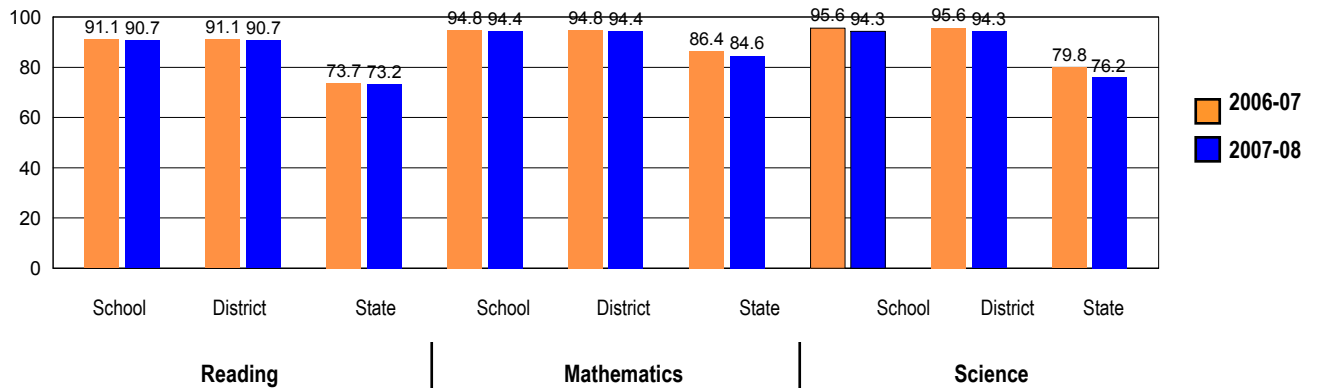

Grade 3



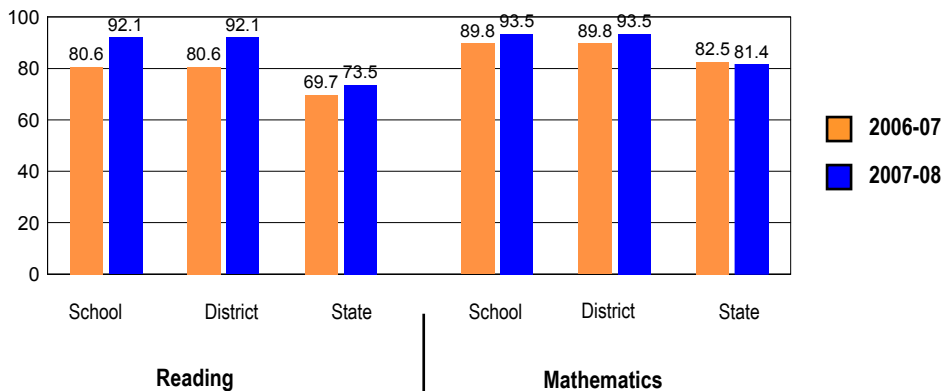

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 62.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 62.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 62.5% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 75% graduation rate for high schools.

School Improvement Plan 2008-2009

Prairie Grove Elementary School is proud of the achievements we've made in the past few years. Our state assessment results have continued to improve and we recently received the Bright Red Apple Award. Our District and School continues to look at state and local data to assess our needs. Our improvement goals are as follows:

The **School Improvement Goal # 1** for Prairie Grove Elementary states, "At least 92% of Prairie Grove Elementary students will meet or exceed standards as measured by the ISAT Reading Test. The components of goal number one are as follows:

- ✓ Assess students in Kindergarten, First Grade, and Second Grade with AIMSweb as a means to monitor their progress.
- ✓ Administer DRA2 twice during the school year.
- ✓ Provide Leadership Team Training to three staff members in implementing sustainable comprehension strategies.
- ✓ Provide materials to staff for implementation of comprehension strategies.
- ✓ Provide guided reading instruction to all students.
- ✓ Continue to create a scope and sequence for Language Arts, to identify gaps and overlaps in the curriculum, align to state standards, and identify power standards.
- ✓ Collaborate with staff in RTI (Response to Intervention) planning.

The **School Improvement Goal # 2** for Prairie Grove Elementary states, "Maintain Positive Behavior Interventions and Supports Universal Systems Implementation at the 100% level in all subcategories as measured on the Benchmarks of Quality, while developing and implementing secondary levels of support." The components of goal number two are as follows:

- ✓ Engage students in structured play utilizing Peaceful Playground Establish to Social Emotional Learning Grant Steering Committee and develop plan.
- ✓ Introduce new Office Discipline Referral (ODR) form and procedures to staff.
- ✓ Establish ROAR Secondary Committee to research, receive training in, and implement Tier 2 levels of support for student behavior.
- ✓ Conduct voluntary staff book study of *Please Stop Laughing at Me* and *Please Stop Laughing at Us* by Jodee Blanco to further develop awareness of social emotional learning.
- ✓ Analyze and present Quarterly school-wide SWIS data.
- ✓ Reviews, selects, and pilots an evidence-based SEL curriculum.
- ✓ Provide SEL staff development opportunities.
