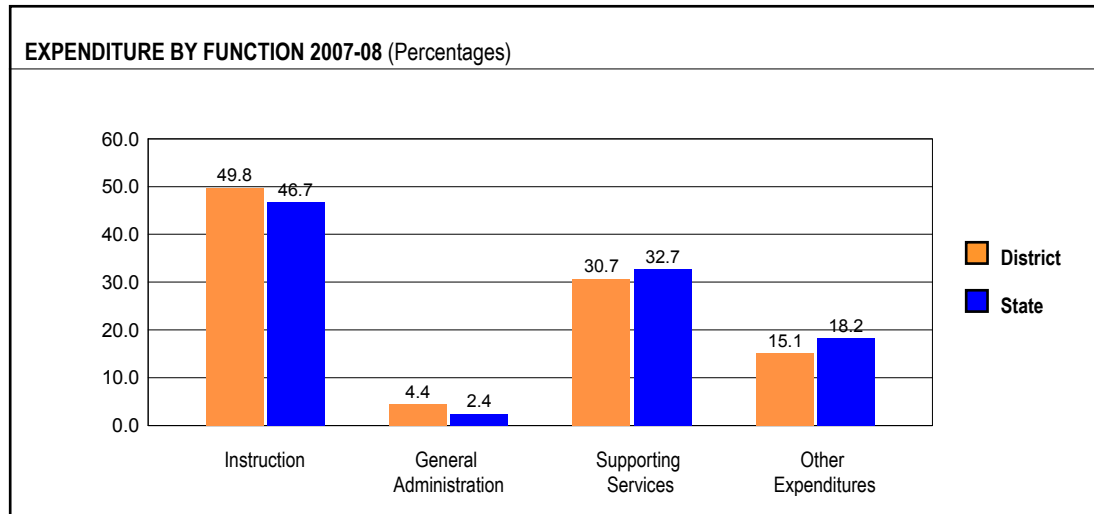

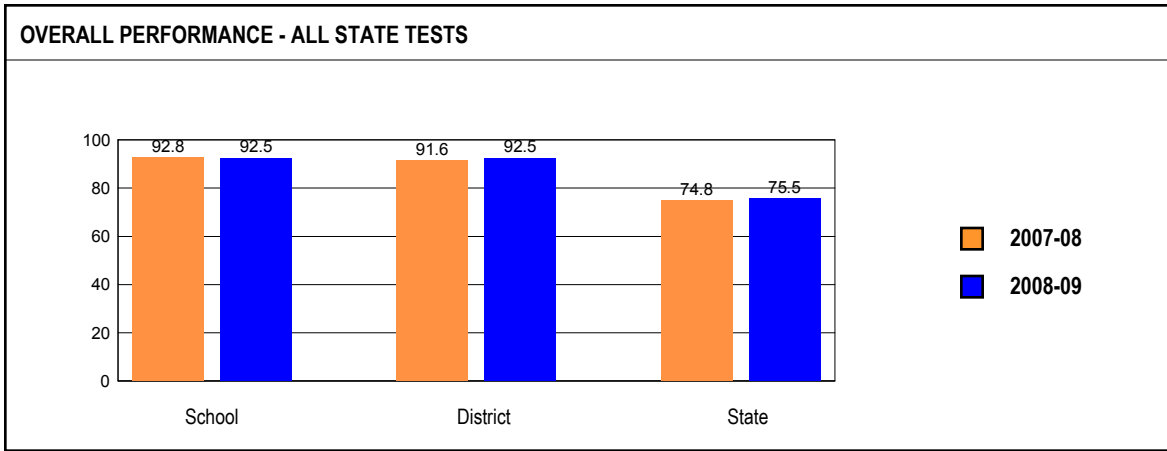

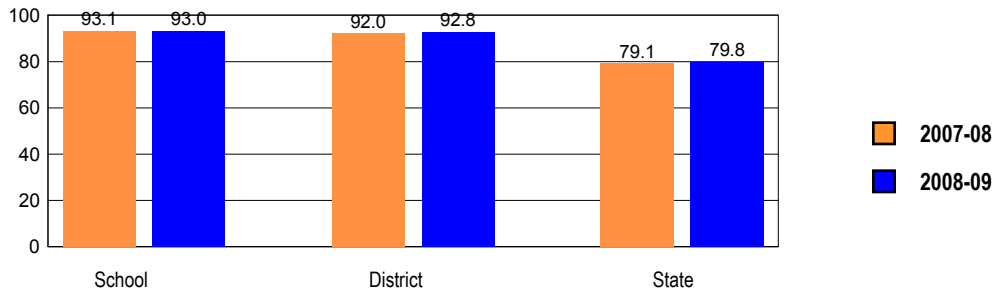
OVERALL STUDENT PERFORMANCE

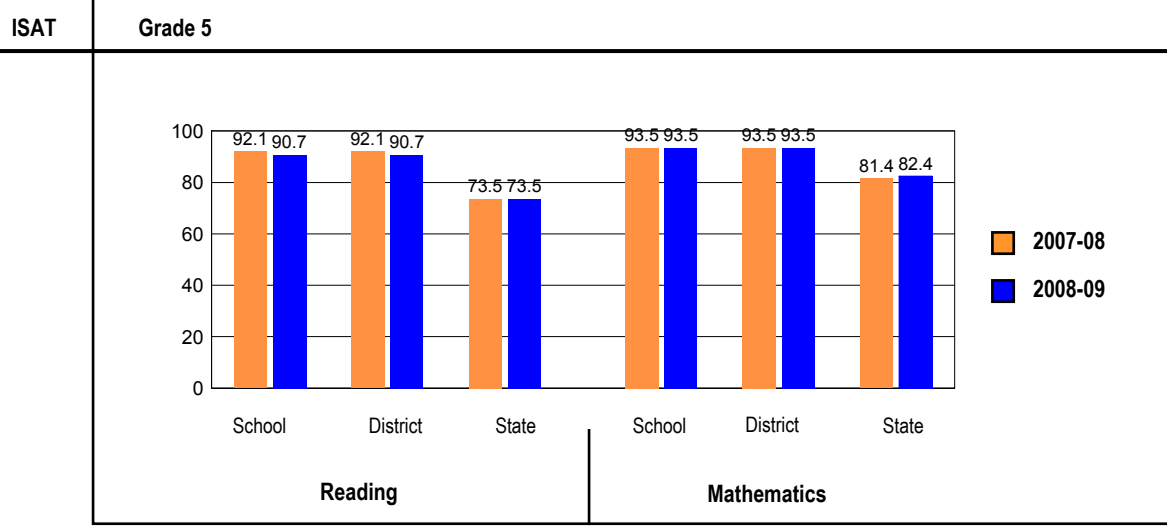
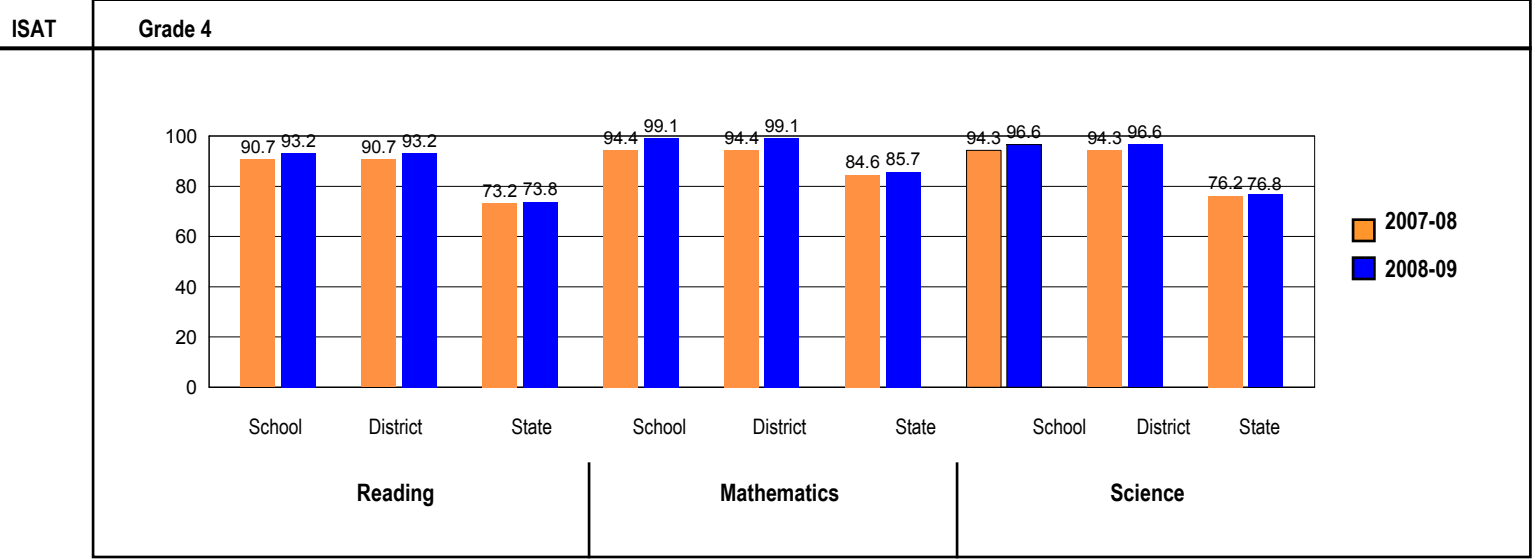
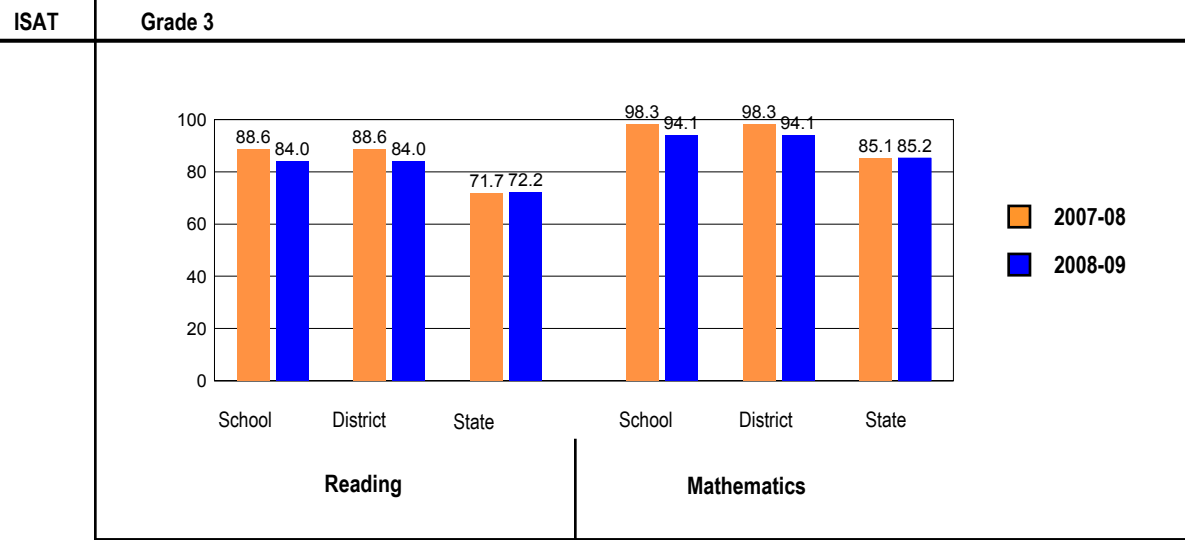


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

Prairie Grove Elementary School

School Improvement Plan 2009-2010

Prairie Grove Elementary School is proud of the achievements we've made in the past few years. Our State Assessment results have continued to improve and we recently received the Bright Red Apple Award for the second consecutive year. Our District and School continue to look at state and local data to assess our needs. Our improvement goals are as follows:

The **School Improvement Goal # 1** for Prairie Grove Elementary states, "Based upon spring Measures of Academic Progress and AIMSweb benchmarking, Prairie Grove Elementary will have increased overall student achievement in reading through implementation of a Response to Intervention model. The components of Goal Number One are as follows:

- ✓ Administer Universal Screening grades K-5 AIMSweb for reading and MAP K-5 for reading and math, as well as progress monitor students in Tier II and Tier III interventions using AIMSweb.
- ✓ Administer diagnostic assessments (DRA2 and Fountas and Pinnell) to further indicate areas of need for identified students..
- ✓ Provide training to staff in utilizing reading comprehension strategies, materials to support strategy instruction, and develop a public information campaign on reading strategies.
- ✓ Provide guided reading instruction to all students multiple times per week using leveled text.
- ✓ Engage students in a consistent reading comprehension strategy language through utilization of Gretchen Courtney staff development.
- ✓ Provide staff a structure and time in formalized data teams.

The **School Improvement Goal # 2** for Prairie Grove Elementary states, "Through continuation of a Response to Intervention model for student behavior and Social Emotional Learning, Prairie Grove Elementary will achieve PBIS "Implementing" status (maintaining the school-wide PBIS foundation and building the foundation for Tier II/secondary level interventions) via the Illinois PBIS FY10 School Recognition Process." The components of Goal Number Two are as follows:

- ✓ Engage students in ROAR Day, where expected student behaviors will be explicitly taught in each location of the school.
- ✓ Provide student behavior with ROAR coupons, quarterly recognitions, and grade level recognitions.
- ✓ Provide students social and emotional learning skills through their participation in Second Step.
- ✓ Identified students will receive secondary level interventions through the PAWS Program, which is a Check-In/Check Out system.
- ✓ Provide staff with professional development in Social Emotional Learning, Positive Behavior Interventions and Supports, Response to Intervention, behavior interventions, and social/academic instructional groups.
- ✓ Coordinate monthly meetings to address behavioral supports at Tier I and Tier II.
- ✓ Inform parents of Social Emotional Learning, Positive Behavior Interventions and Supports, Response to Intervention via school and classroom media sources.
