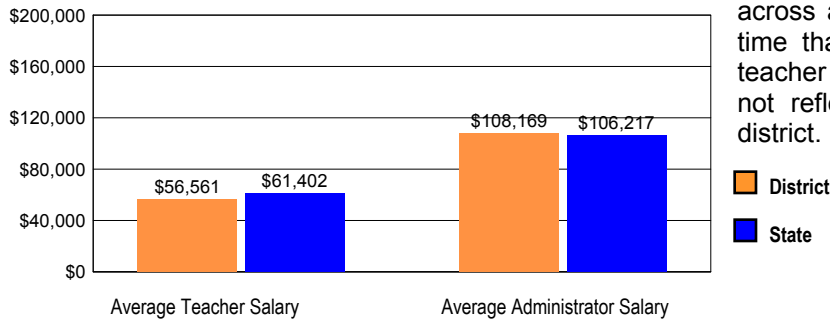

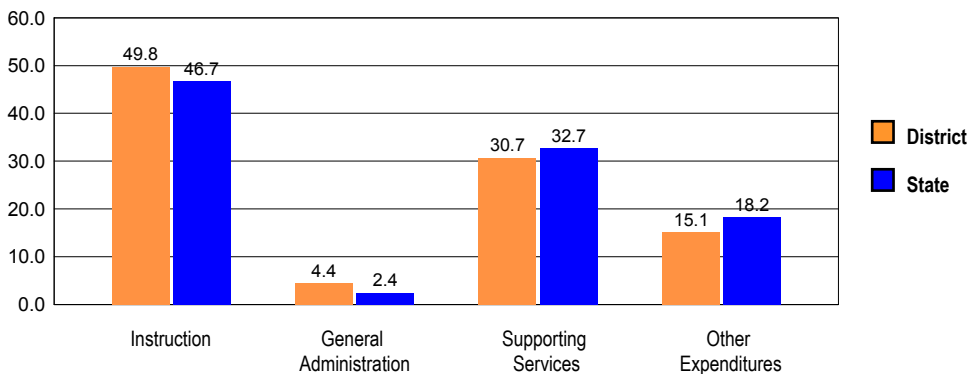
SCHOOL DISTRICT FINANCES

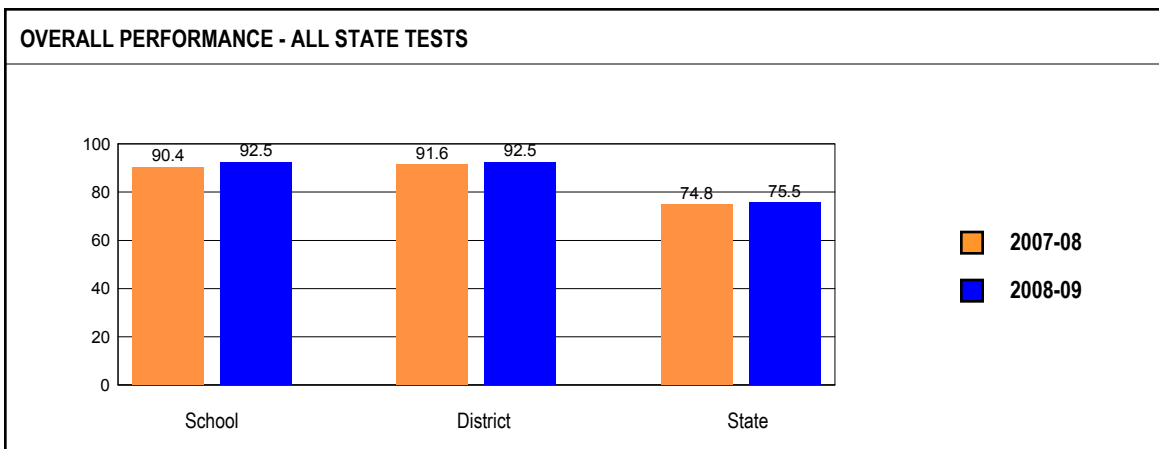

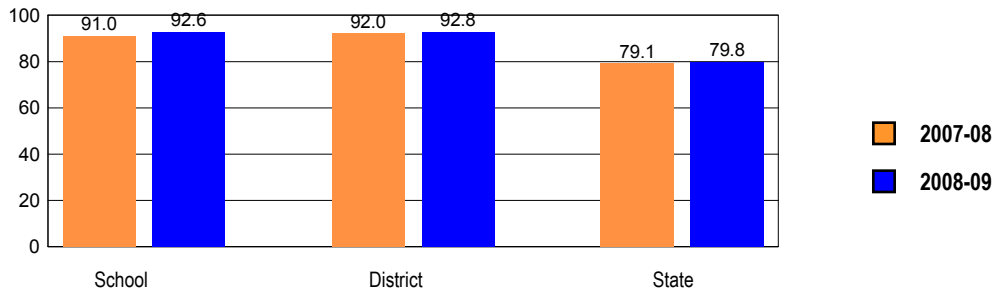
OVERALL STUDENT PERFORMANCE

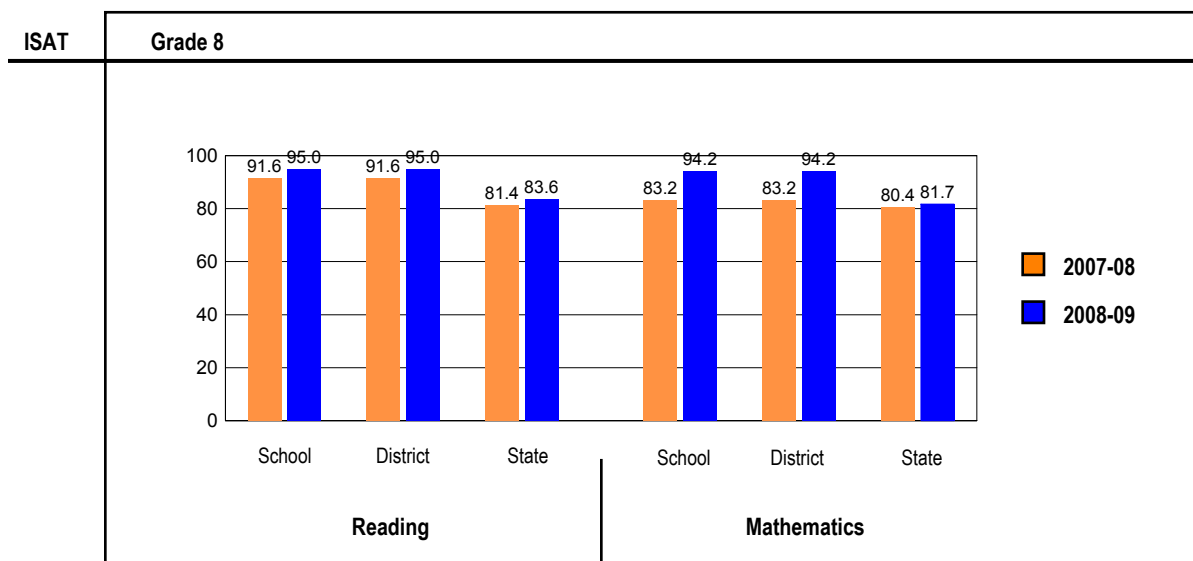
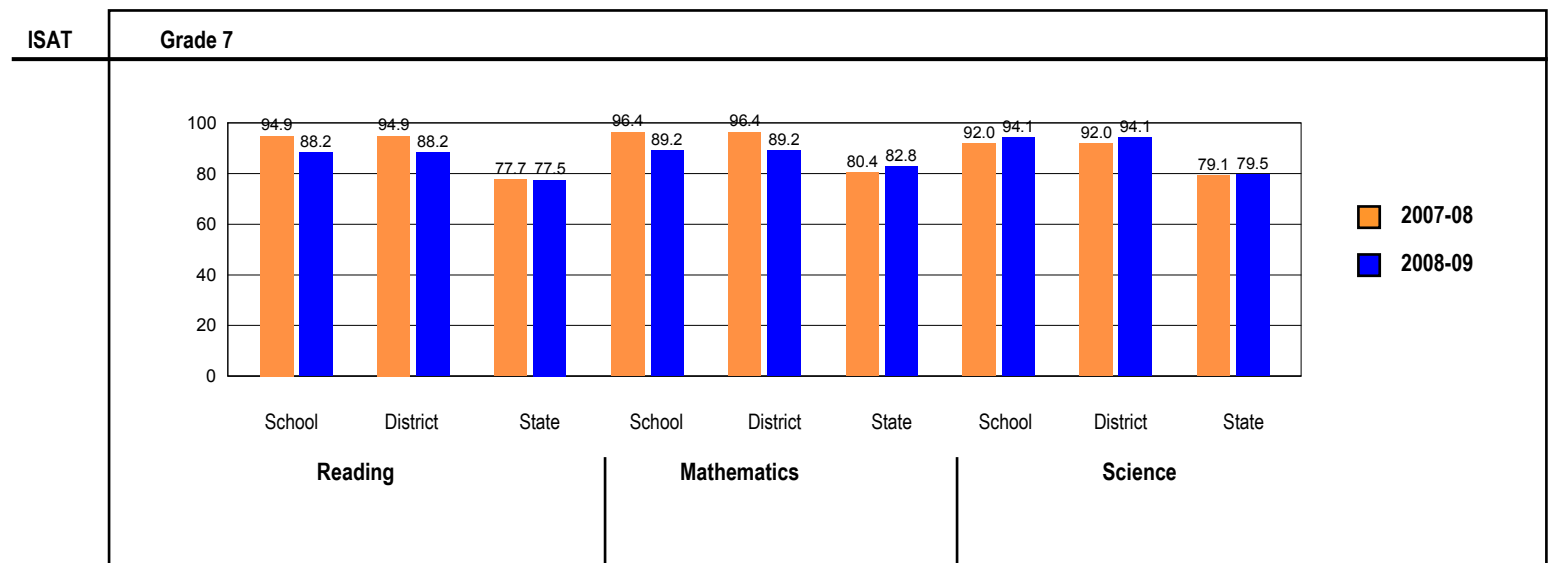
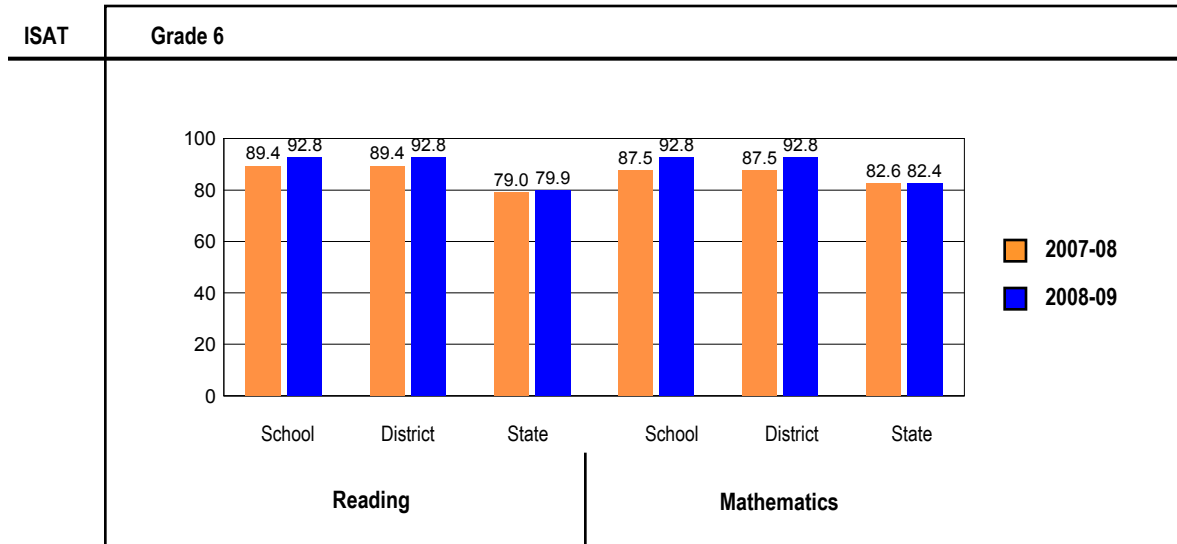


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

School Improvement Plan 2009-2010

Prairie Grove Junior High School is an academically excellent and responsive learning community. While we are pleased with our ongoing successes, we look forward to progress in the future. Our District and schools continue to look at state and local data to assess our needs. In response to the data we have determined annual improvement goals as follows:

The **School Improvement Goal # 1** for Prairie Grove Junior High states that “The Prairie Grove Junior High School learning community is going to commit to research and implementation of differentiated instructional techniques, by introducing and training teachers in two new techniques per quarter.”

- ✓ Preliminary student interest survey and learning styles inventory.
- ✓ Professional development opportunities.
- ✓ Professional library materials to aide in the research of differentiated instructional techniques.
- ✓ Interviews with student survey group, to determine their level of interest and perception of learning adaptability within the classroom.
- ✓ Monthly SIP team meetings to research, develop, and present differentiated practices based in research.
- ✓ Monthly department level meetings to reflect upon the effectiveness of differentiated instructional techniques.
- ✓ Classroom walk-through process, to collect data, indicating the presence of differentiated techniques in the live classroom environment.
- ✓ Collaboration with team members to critique implementation and techniques.

The **School Improvement Goal # 2** for Prairie Grove Junior High School states “The Prairie Grove Junior High School learning community will implement a system of reading strategies which will improve student achievement on the Reading portion of State Assessments. Our goal is to improve the percentage of students “Meeting or Exceeding Standards”.

- ✓ We will develop common vocabulary regarding the instruction of reading across all content areas.
- ✓ We will develop a common rubric for reading across the content areas.
- ✓ We will also develop common rubrics for the other components of literacy, which are closely associated with success in reading. These will include the skills of active listening, writing, viewing, visually representing, and speaking.
- ✓ We will study and provide professional development activities in the “6 Traits” technique for learning literacy.
- ✓ We will analyze reading progress through the collection data on common assessments. We will use Measures of Academic Progress and AIMSWeb benchmarking for this purpose.
- ✓ We will intervene for students at risk, in accordance with our RtI procedures and programs.
